

User Agreement on Personal Data Processing

Bernadini Global Connections FZE

By registering on the Website or completing a questionnaire, the user consents to Bernadini Global Connections FZE processing their personal data on the terms below. Fields in square brackets are to be completed before publication.

1. Parties and form of consent

1.1. I, a user of the website (the "User"), freely, of my own will and in my own interest, give consent to Bernadini Global Connections FZE, Sharjah Publishing City Free Zone, Emirate of Sharjah, UAE, licence No. 4431384.01, address: Business Centre, Sharjah Publishing City Free Zone, Sharjah, United Arab Emirates (the "Agency"), to process my personal data.

1.2. I confirm that I am at least 18 years old, have full legal capacity and provide accurate information about myself.

1.3. Consent is given by completing and submitting a form on the Website, or by confirmation via a messenger or email. Such consent is equivalent to consent signed by hand.

1.4. I confirm that I have read the Agency's Privacy Policy and Public Offer. Terms in this Agreement have the meanings given in those documents.

1.5. If I provide the Agency with data of third parties (for example, when recommending an acquaintance), I confirm that I have obtained their consent to such disclosure.

2. What data, for what purposes, and how it is processed

2.1. This consent covers the following data:

1. name, gender, citizenship;
2. country and city of residence;
3. phone, email, messenger and social media accounts;
4. marital status, children, education, occupation, field of work;
5. appearance, photos and video;
6. interests, lifestyle, habits, languages, expectations of a partner;
7. information about meetings with Candidates and feedback on them;
8. payment data: payment method, amount;
9. technical data: IP address, cookies, device information.

2.2. Purposes of processing:

1. conclusion and performance of the public offer agreement;
2. selecting Candidates and arranging introductions;
3. identity verification for the safety of participants;
4. communicating with me about the services;
5. receiving payments and record-keeping;
6. improving the Website and the service.

2.3. Processing operations: collection, recording, organisation, accumulation, storage, updating, retrieval, use, transfer (provision, access), anonymisation, blocking, erasure and destruction — with or without automated means.

2.4. I consent to my data being shared with:

1. Candidates — to the extent agreed with me and only after I approve a specific Introduction; contact details only by mutual consent;
2. public authorities — only upon a lawful request.

3. Separate consents

3.1. Sensitive data. If I choose to state in my questionnaire my religious beliefs or ethnic origin relevant to matching, I give explicit consent to its processing solely for selecting Candidates. This information is not shown to Candidates without my separate permission.

3.2. Photos and video. I allow my images to be used in the profile shown to Candidates. My images may be used in advertising, on the Website or on the Agency's social media only with my separate written consent.

3.3. Newsletters. Consent to informational and promotional newsletters is given separately and is not a condition of the services.

4. Term and withdrawal

4.1. This consent is valid from the moment it is given until the purposes of processing are achieved or until it is withdrawn, but no longer than the periods set out in the Privacy Policy.

4.2. I may withdraw consent in full or in part by sending a request to the Agency via messenger or social media. The Agency stops processing and deletes the data within [30] days, except for data that must be kept by law.

4.3. I understand that withdrawing consent to share data with Candidates makes matchmaking services impossible, in which case the agreement terminates under the terms of the public offer.
